ATTENDANCE AND EXEMPTION TESTS

At the end of every lesson or other integrative teaching activity, signatures proving attendance will be collected.

At the end of every training module, the students who will have attended at least the 75% of the total number of lessons and other integrative teaching activities will be admitted to take one or more exemption tests. These tests will consist of questions concerning a judgment or another legal document with "open" answers. The evaluation will be individual and assessed through votes out of thirty, followed by a collective discussion. The passing of each test will imply the possible exemption of the corresponding part of the programme during the exam. It is possible to refuse one or more vote. In this case the exemption test will not be considered for the corresponding part of the programme.

LEGAL CLINICS

Beside the course, a "legal clinic" will be organized. Teams of students regularly attending the lessons (as for the exemption tests) will prepare and discuss, in writing and/or orally, a case raising issues of European Union Law. Minimum and maximum participants: nine/fifteen. In case of too many students asking to participate, students with the best assessment for the exemption test will have priority. The participation in the Legal Clinic will be individually evaluated and will be taken into consideration for the final exam.
